13/2025 COUNCILLOR'S PORTFOLIO'S

- i) Allotments: M. Abbott said that the allotments were very wet. The clerk advised that the rents were due next month, and all agreed that the rents were to remain the same as last year. - ii) Play Park: K. Faulder stated it is very wet at present.
- iii) Flooding: S. Barton stated that the flood gates had been deployed but there were no issues.
- iv) Outside bodies: J. Mansfield attended Fells and Solway Community Panel at Caldbeck and found it rather intimidating. The next meeting is in March.

14/2025 HEDGES TO THE FRONT OF WEST STYREET

Following complaints the clerk had reported the hedges which overhang the footway to highways. They have reported back to say that there are no hedges overhanging the footway.

15/2025 BAGGROW LONNING

Work is ongoing. The contractors have now located the pipe leading to the beck which they intend to jet to complete the work.
